I. Supplier of the Applicant Tracking Software – JobMatch LLC.

II. Name of the Applicant Tracking Software – iApplicantsTM

1. Functions: iApplicants is a web based software program introduced and developed by the Supplier that is designed to host and manage the career website of the Client. The System tracks all of the job openings and applicants of the Client.

2. LICENSE FEES AND PAYMENT In consideration of the rights granted herein, Licensee shall pay to MAF an annual license fee of nine hundred ninety dollars U.S. (U.S. \$990.00).

3. Features: Client will be provided a System that includes the standard features (covered in the "Guide to your iApplicants System" document) as of the date of this contract. Supplier will notify the Client of additional features, both standard and premium, that have been added to the System via a web page in the admin area of the System. It is the responsibility of the Client to contact the Reseller to request the adding of new updates to their System.

4. Privacy: There is no disclosure of Customer's information to any third parties be it external or internal. Customer's information is only accessible by Customer's designated users. All records are protected, by such security safeguards as it is reasonable in the circumstances to take, against loss, against unauthorized access, use, modification or disclosure, and against other misuse.

III. Obligations of Supplier:

1. Provide Client with a custom branded sub-domain of iApplicants.com. The Supplier will host and manage the database as well as the client's website
2. Supplier will maintain the software and database, which includes all hosting and maintenance costs.
3. Supplier will handle all technical support not provided by the Reseller.

IV. Obligations of Client:

1. The Client will manage the day to day operations of their career site, which includes adding/editing job openings and applicants.

V. Obligations of the Reseller:

1. The Reseller will help the Client in setting up their iApplicants system, as well as provide training and an instructions manual for using the system. Reseller will provide first level customer support and pass any issues onto the Supplier if they cannot resolve them to the Client's satisfaction.

VI. Intellectual property protection and overhead expenses

1. Supplier reserves the copyright of the System as well as all other websites and programs designed and managed by Supplier. Client shall not use the product beyond the scope stipulated in this agreement. Clients further agrees not to, or allow a 3rd party to, use the documents provided about the System or access granted to the System for the purpose of reverse engineering the System.

3. Neither of the parties shall use, duplicate, and spread without authorization, the related cooperator's trademarks, logos, and business information, technology...etc.

4. Supplier possesses the intellectual property right of the System and all the other related extension products.

VII. This agreement, after its being signed, shall remain in force for 1 year, and it shall be extended upon expiration into the future in 1 year increments. Each party shall submit a request in writing 60 days ahead to terminate the agreement through friendly consultation. Upon termination of this agreement, within a reasonable period of time, the supplier will provide the information then housed in the suppliers computers all information pertaining to the customer in the form of a CD or other media that is acceptable to both parties
